A native boy while playing on a monkey-pod tree on Liliha street Sunday afternoon fell some thirty odd feet to the ground and a shoulder blade was dislocated besides some internal injuries. The boy is getting on finely under treatment of a Japanese physician, who was called in to attend to him soon after the accident.

Kaluna and Wm. Hoopii (bare-footed Bill) were arrested yesterday and charged with burglary in connection with the robbery of W. W. Dimond's store. A continuance was granted in the District Court this morning till Friday. Kaluna also will have to answer to a charge of being unlawfully on the premises of another to wit the Queen's Hospital.

TOPICS OF THE DAY.

The action of President Dole in asking the Court of Claims to adjourn sine die was, to say the least, remarkable, although very characteristic of the man. When he realized that he had made a blunder and that he could not stand the pressure of public opinion, besides the Orientals, why did he not ask the Court for their resignations instead of placing the members in a false light and the Government in a ridiculous position? He simply played the baby act by sulking because he was defeated and threw the responsibility for the whole affair onto the Council of State.

The younger Hawaiian generation should do its utmost to learn the English language even at the cost of their mother tongue. The territorial bill passed in the Senate provides that no man can hold a seat in our territorial legislature except he speaks English and that the business in both houses shall be transacted in the English language only. It means that there will be no interpreters. It also provides that no man can serve on a jury except he speaks the English language and it does away with the Hawaiian juries. Learn the language boys, if you wish to have a voice in the affairs of Hawaii.
