Certificates of Deaths.

THURSDAY'S RECORD.

Ana Mailou, Hawaiian female, 19 years; died at Pauoa, lane off Punchbowl street, south side of Boyd premises by butcher shop, of phthisis pulmonalis; attended by Dr. Alvarez; Makiki cemetery.

FRIDAY'S RECORD.

Samuel M. Kekoa, Hawaiian male, 76 years; died on Punchbowl street, mauka of Queen, at Ah Leongs premises, of cancer of the stomach; attended by Dr. Alvarez; Kawaiahao cemetery.

Chun Pun Lin, Chinese male, 16 years; died at the Chinese Hospital of typhoid fever; attended by Dr. Hodgins; Manoa cemetery.

Infant of Keioloa Haina, Hawaiian female, stillborn; Liliha street, Ewa side below School street; unattended; Kalaepohaku, the hill cemetery above the Insane Asylum.

Infant of Mrs. G. D. Adams, American female, 10 hours; died at 539 Beretacia St., nr. Punchbowl, of premature birth; attended by Dr. Herbert; Catholic cemetery.

Hoopii Honoli, Hawaiian female, born at Kaanapali, Maui, 60 years; has been sick for 6 months and died at Kakaako, just on the Waikiki side of the new Iron Works, of phthisis pulmonalis; attended by Dr. Cooper; Kalaepohaku cemetery.

Kamila, Hawaiian female, born on the island of Hawaii, 24 years; has been sick for 3 months and died at the Insane Asylum; attended by Dr. Herbert; Paea cemetery.

Babe of Nenosaku Takaki, Japanese female, 7 days; was sick only one day and died in Nuuanu Valley, where the babe was born, on the Ewa side of road mauka of the Electric Light Station, of acute peritonitis; attended by Dr. Ogawa; Makiki cemetery.

The Arrest of the Reformers.

SHANGHAI, March 16.

Yu Taotai of this port, who went to Nanking last week, concerning whose absence there was considerable conjecture, returned to port on Tuesday evening. It is now reported that his Honour went to Nanking specially to report to acting Viceroy Lu Ch'uan-lin the great difficulty of obeying the recent Imperial decree commanding the arrest of a large number of members of the Reform Party known to be residing in the Foreign Settlements of Shanghai. The principal reason given was the protection given to the Reformers by the Municipal authorities of the Cosmopolitan Settlement and the refusal of the British, United States, and other Consuls to permit the serving of Chinese warrants in this connection within the limits of Foreign Settlements. As without this permission it is impossible to arrest anyone inside the Settlements, and owing to the wide publicity given by the foreign and native newspapers of the intended arrest of Reformers by the Government, which prevented the local authorities from inviting the Reformers wanted in to Chinese jurisdiction, the probability will be that a long time—years perhaps—must elapse before there will be any possibility of executing the warrants issued, if ever. This conference resulted, it is stated, in acting Viceroy Lu Ch'uan-lin telegraphing the substance to Peking, endorsing Yu Taotai's objection and asking for further instruction. With reference to the above decree, news has been received from Canton that Viceroy Li Hung-chang has also sent word to Peking on nearly the same subject. He stated that so long as the Reform Party received the sympathy of foreign States and those who visited their countries were protected by local Governments, so long would it be impossible to effect the arrest of any Reformers, regardless of the status of the man. Viceroy Li's advice was, therefore, that after punishing those who had been caught as a warning to others, the Empress Dowager

should proclaim an amnesty to the Reformers on the understanding that they refrain in the future from criticising the government and eschew the doctrines of Kang Yu wei and Liang Ch'i-chao. A similar "amnesty" it will be remembered was issued in September, 1897, after the execution of the six martyrs to Reform at Peking.—N. C. D. News.
