### Court Notes.

A decision by Judge Perry has been filed in a bill for accounting, brought by Virginia Gomes, widow, vs. The Portuguese Mutual Benefit Society. It is a sick benefit case, where the husband of complainant, Francisco Gomes Capicha, was operated upon for a fee of \$800, charged by Dr. Kobayashi, but which was subsequently reduced one-half, and before the performance of said operation, the said Capicha, now deceased, together with his wife executed a certain promissory note for \$400 in favor of the Society. When Capicha died, after the operation, his widow was entitled to receive \$899 from the members of the Society, and the Society tendered to complainant before the institution of these proceedings \$499, less the \$400 of the note, being the full amount due her. The Court decrees that complainant can only recover the \$499 without costs. J. M. Vivas and A. G. Correa for complainant, J. T. De Bolt for respondent.

In the estate of Jno. P. Parker, deceased, the final receipts of the heirs are placed on file.

A petition for letters of administration in the estate of J.M. Camara, deceased, has been filed by Claudina J. Camara, widow, praying that Augusta Bell be appointed administratrix. The real estate is a piece of land in North Kona, Hawaii, valued at \$1,000, and the personal estate is a piece of leased land in said North Kona valued at \$200. His heirs are the widow, now resident in Hilo, J. M. Camara, Jr., a son, Augusta Bell and Adelaide S. Marques, daughters, the last three being residents of Honolulu.

Kalanihuia, one of the defendants in the ejectment suit of Leong Duck vs. Kalanihuia and O. J. Holt, files his answer by T. McCants Stewart, his attorney, denying the truth of the facts stated.

A replication has been filed by J. Alfred Magoon and I. M. Long, attorneys for E. M. Magoon in her bill to quiet title against L. E. Lucas, wherein the plaintiff says that her bill is true, and that defendant's answer is not true, and this she is ready to prove.

A joinder in demurrer is filed by plaintiffs attorneys, J. Alfred Magoon and I. M. Long, in See Hau et al. vs. Chee Kit et al., saying that their bill is sufficient in substance and in law.
